The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

(Period of deputation (including Short Term Contract) including period of deputation (Including Short Term Contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/ department of the Central Government shall ordinarily not to exceed five years. The maximum age limit for appointment by deputation (including Short Term Contract) shall not be exceeding 56 years as on the closing date of receipt of application

**Note :** The Departmental Additional Chief Planner in the pay matrix of Level 13 with three years' regular service in the grade, failing which by Additional Chief Planner with eight years of combined regular service in the grades of Additional Chief Planner in the Pay Matrix of Level 13 and Town & Country Planner in the Pay Matrix of Level 12 shall also be considered for appointment to the post alongwith outsiders and in case he/she is selected for appointment, the post shall be deemed to have been filled by promotion.
