OFFICE ORDER

In pursuance of DOPT's OM No.4/2/2006-CS.II(B) (Vol.II) dated 28.12.2018 and in continuation of this Ministry's Office Order of even number dated 12th September, 2018, the period of the ad-hoc appointment of those Senior Secretariat Assistants of CSCS who are working as Assistant Section Officers (ASO) of CSS Cadre of this Ministry on ad-hoc basis (**as per annexure**) has been extended for a further period upto **30.06.2019** or till regular Assistant Section Officers become available, whichever is earlier.

2. The continuation of ad-hoc promotion in the post of ASO of CSS is purely ad-hoc in nature and shall **not** confer any right on them to continue in the posts indefinitely or to claim seniority in the Grade of ASO of CSS. Further, the extension of the ad-hoc appointment would be continued only if the ad-hoc ASOs attend and qualify the mandatory 'A' Level training as and when nominated by CS.I (Training) Section of DOPT failing which their ad-hoc appointment would be terminated. Other terms and conditions mentioned in the relevant O.Ms/Office Orders will remain unchanged.

3. All concerned offices are requested to take note of it and bring the contents of this Order to the notice of all the concerned ad-hoc ASOs as per Annexure attached, working under them.
